

ORDINANCE #07-37

ORDINANCE OF THE TOWNSHIP OF LACEY, COUNTY OF OCEAN, STATE OF NEW JERSEY, AMENDING AN ORDINANCE ENTITLED "AN ORDINANCE OF THE TOWNSHIP OF LACEY, COUNTY OF OCEAN, STATE OF NEW JERSEY, AFFIXING AND DETERMINING THE SALARIES, WAGES AND COMPENSATION OF THE OFFICERS, EMPLOYEES AND MEMBERS OF THE GOVERNING BODY OF THE TOWNSHIP"

BE IT ORDAINED by the Township Committee of the Township of Lacey, County of Ocean, State of New Jersey, as follows:

SECTION 1. Section 1 of the salary ordinance shall be amended to reflect the following wages for the following officers, employees and members of the governing body of the Township of Lacey:
