

ORDINANCE #2008-04

**ORDINANCE OF THE TOWNSHIP OF LACEY,  
COUNTY OF OCEAN, STATE OF NEW JERSEY,  
AMENDING AN ORDINANCE ENTITLED "AN  
ORDINANCE OF THE TOWNSHIP OF LACEY,  
COUNTY OF OCEAN, STATE OF NEW JERSEY,  
AFFIXING AND DETERMINING THE SALARIES,  
WAGES AND COMPENSATION OF THE  
OFFICERS, EMPLOYEES AND MEMBERS OF THE  
GOVERNING BODY OF THE TOWNSHIP"**

**BE IT ORDAINED** by the Township Committee of the Township of Lacey,  
County of Ocean, State of New Jersey, as follows:

**SECTION 1.** Section 1 of the salary ordinance shall be amended to reflect the following wages for the following officers, employees and members of the governing body of the Township of Lacey:

**SECTION 3.** The salaries, wages, and other compensation listed in Section 1A above shall be retroactive and payable from January 1, 2008 or the date of employment, whichever is the latter.

**SECTION 4.** All ordinances or parts of ordinance inconsistent herewith are hereby repealed.

**SECTION 5.** This ordinance shall take effect after second reading and publication as required by law.
