

ORDINANCE #2008- 33

**ORDINANCE OF THE TOWNSHIP OF LACEY, COUNTY OF OCEAN,
STATE OF NEW JERSEY, AMENDING AN ORDINANCE ENTITLED
"AN ORDINANCE OF THE TOWNSHIP OF LACEY, COUNTY OF
OCEAN, STATE OF NEW JERSEY, AFFIXING AND DETERMINING
THE SALARIES, WAGES AND COMPENSATION OF THE OFFICERS,
EMPLOYEES AND MEMBERS OF THE GOVERNING BODY OF THE
TOWNSHIP"**

BE IT ORDAINED by the Township Committee of the Township of Lacey, County of Ocean, State of New Jersey, as follows:

SECTION 1. Section 1 of the salary ordinance shall be amended to reflect the following wages for the following officers, employees and members of the governing body of the Township of Lacey:

A. Special Law Enforcement Officer -Class I (per hour)

Step 1 (1 st year of service)	\$9.25
Step 2 (2 nd year of service)	\$9.75
Step 3 (3 rd year of service)	\$11.00
Step 4 (4 th year of service)	\$12.25
Step 5 (10 years of service)	\$13.00

B. Special Law Enforcement Officer - Class II (per hour)

Step 1 (1 st year of service)	\$12.50
Step 2 (2 nd year of service)	\$13.25
Step 3 (3 rd year of service)	\$14.00
Step 4 (4 th year of service)	\$14.50
Step 5 (10 years of service)	\$15.50

SECTION 2. Any salary, wage or compensation not hereinbefore mentioned shall remain the same hereto before.

SECTION 3. The salaries, wages, and other compensation listed in Section 1A, 1B and 1C above shall be effective the date of adoption or the date of employment, whichever is the latter.

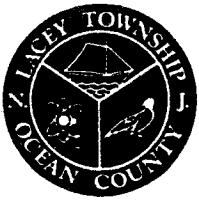
SECTION 4. All ordinances or parts of ordinance inconsistent herewith are hereby repealed.

SECTION 5. This ordinance shall take effect after second reading and publication as required by law.

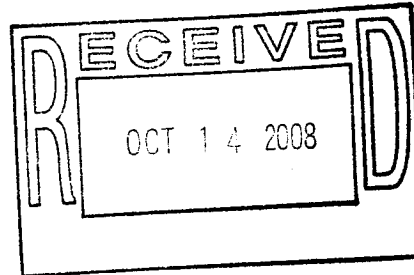

I would like to once again request your consideration in this matter as we have some officers who have served the department and the township with distinction for many years and have not received a raise in over three years.

1. Special Law Enforcement Officer – Class I (hourly)

Step 2 (2 nd year of service)	\$9.50	\$9.75
Step 3 (3 rd year of service)	\$10.50	\$11.00
Step 4 (4 th year of service)	\$11.75	\$12.25
Step 5 (10 years of service)	\$ N/A	\$13.00

2. Special Law Enforcement Officer – Class II (hourly)
